PETER knew Jesus was the Christ, the Son of the living God. He'd said so already (see Matthew 16:16). But apparently he didn't really understand all he'd said. - **3.** Write in the clouds what the disciples heard and underline the words you think were emphasized.
- 4. Who is Jesus?
- **5. Read Matthew 17:9-12.** Why do you think Jesus told His disciples not to tell anybody what they had seen?

- 7. What did Peter learn from this experience?

Matthew 17:1-12

¹After six days Jesus took with him Peter, James and John the brother of James, and led them up a high mountain by themselves. ²There he was transfigured before them. His face shone like the sun, and his clothes became as white as the light. ³Just then there appeared before them Moses and Elijah, talking with Jesus.

⁴Peter said to Jesus, "Lord, it is good for us to be here. If you wish, I will put up three shelters—one for you, one for Moses and one for Elijah."

⁵While he was still speaking, a bright cloud covered them, and a voice from the cloud said, "This is my Son, whom I love; with him I am well pleased. Listen to him!"

⁶When the disciples heard this, they fell facedown to the ground, terrified. ⁷But Jesus came and touched them. "Get up," he said. "Don't be afraid." ⁸When they looked up, they saw no one except Jesus.

⁹As they were coming down the mountain, Jesus instructed them, "Don't tell anyone what you have seen, until the Son of Man has been raised from the dead."

WHEN'S THE LAST TIME SOMEONE FAKED YOU OUT? OR YOU FAKED OUT SOMEONE ELSE?

Nature fakes us

out all the time because God gave many creatures the ability to trick their enemies. For example, whenever the cuttlefish is in danger, it eiects a dark ink to hide itself. What a great fake-out!


But Jesus accomplished the greatest fake-out of all time. He fooled Satan and death when He rose from the dead.

Jesus' resurrection makes it. possible for us to fake out Satan and death too. When we trust Jesus, we become new people: "Therefore, if anyone is in Christ, the new creation has come" (2 Cor. 5:17a).

So if you really want to fake people out, let them see what a difference Christ makes in the way you talk and act!

- **7.** Stir together 1/4 cup of tomato soup and 1/8 cup water in a small saucepan. Cover, bring to a boil; then simmer for 20 minutes. Keep an eye on it, because the soup quickly comes to a boil.
- **2.** Fill a large saucepan with water, and boil and sterilize 2 small heat-resistant cups, 2 sheets of plastic wrap at least 2 times larger than the tops of the cups, a metal spoon, and tongs.
- **3.** Remove the tongs by the handle with a fork, and let them cool in a glass baking dish.
- 4. When cool, use the tongs to remove the spoon and one cup, draining the water out of it. Don't touch the insides with your fingers.
- **5.** Using the sterilized spoon, put spoonfuls of the soup into the cup. After it cools, touch a finger to the surface. Then remove a sheet of the plastic wrap with the tongs and spread it open. Cover the cup with the plastic, and hold it in place with a rubber band.
- **6.** Repeat step 5 with the other cup, but rub your finger on the floor before touching the soup.
- 7. In three or four days, plants will begin to grow in the soup even though you didn't plant seeds.







MONDAY Read John 14:6. Make a one-way sign and print the name "Jesus" on it. Post the sign in your room or locker as a reminder that Jesus is the one and only way to God and heaven. Have you trusted Jesus as the way to God?

WEDNESDAY Create a rebus (a sentence with words, pictures, and symbols) for John 14:6. Come up with symbols or word pictures for the words "way," "truth," and "life." Use your rebus to help you memorize this verse.

THURSDAY Jesus' gift to us is life, eternal life. Write a short description of how someone can receive Jesus' gift. If you don't know what to write, talk to a Christian friend or adult who can help you.

FRIDAY Read John 14:9-10. Close your eyes and imagine what it would be like to sit down and talk with Jesus face-to-face. What questions would you ask Him? When you pray today, remember that Jesus is with you, so ask Him those questions!

SATURDAY Read John 14:6 again. Jesus is the *only* way to God, but some people say there are other ways to God. Write down one of these wrong ways. Can you explain why Jesus is the way, the truth, and the life?
